Team Activities

Learning Activity 1: Context

An examination of the environment of projects, ie, social, economic, political, legal, etc. The case for people management and leadership. An overview of innovative concepts and techniques.

Learning Activity 2: Personal and Interpersonal Competence

Exploration of personal competence including self-awareness, and regulation, instinct, motivation, leadership, learning, performance and recognition. Development of interpersonal competence including social proficiency, communication, coaching, conflict resolution, power, authority, influence, negotiation, making decisions and stakeholder consultation.

Learning Activity 3: Team Competence

Development and management of teams and stakeholders including governance, teamwork and the psychology of teams.
